The future of Olde Coloma Theatre is in peril!

On Thursday, January 14, 2010 we met at the Planning Commission. Our Special Use Permit was postponed for six weeks. The result of the meeting was that we are going to have to completely restructure our parking lot, install a commercial fire alarm system and a fire protection water tank among other improvements to the theatre. These improvements are going to cost more revenue than we can generate.

El Dorado County Planning Commission plans to issue our Special Use Permit at their February 25, 2010 meeting. The Special Use Permit conditions may restrict our operations so much and cost more money than we can afford. Thus, we may be forced to close our doors permanently.
